Subscription renews automatically annually if not terminated with a written three-month advance notice which cannot take effect before the end of the Minimum Subscription Term. The order requires a full annual up-front payment for each year.

This Service Contract incorporates One Click LCA and SimaPro General Service Terms (https://www.oneclicklca.com/service-terms/), as well as the terms of third-party Databases referenced below, and applies the laws of the Netherlands to the exclusion of other jurisdictions. Any dispute arising out of or in connection with the contract shall be subject to the exclusive jurisdiction of the Netherlands Commercial Court (NCC) in Amsterdam, the Netherlands. These terms also apply to additional orders placed by the Customer. Any and all general terms and conditions of the Customer are excluded. Customer agrees that any purchase order (PO) submitted is for administrative purposes only, and that any terms or conditions appearing on the PO that are additional or different from this Service Contract are not binding to the Supplier or applicable to the contract, also when the services specified by the order are delivered and invoiced against such PO.
